Preparations

Remove loose dirt and grit from your floor. Clean floor thoroughly with Bona Wood Floor Cleaner and let dry. Do not use over any floor that has been waxed or oiled. Wax and oil residues will prevent proper adhesion of Bona Wood Floor Refresher to floor. If uncertain, perform a small test before use.

Shake bottle thoroughly before use and apply at normal room temperature, 18-25°C.

Instructions for use

- 1. Pour a wide, wavy line of Wood Floor Refresher on a small section of the floor.
- 2. Spread the product over the section using a Bona Applicator Pad.
- Complete section by smoothing with the applicator pad in the direction of the wood.
- 4. Continue section by section until the whole floor has been treated.

The floor can be walked on already after 2 hours but avoid heavy traffic and replacement of furniture and rugs the first 12 hours.
