PREPARING THE SUBSTRATE:

Make sure the surface is clean and free of oil, wax and loose parts. Any dust residue, loose fragments or residue of incompatible products must be removed. In case of application on non-porous surfaces abrade the surface with sandpaper. When in doubt, it is advisable to test the product on a small area. Concrete dusty sub-floors or sub-floors with moisture must be treated beforehand with our primers to optimise adhesion of the product.

APPLICATION:


Pour component B into the container of component A and mix thoroughly until an even, uniform paste is obtained. This paste must be spread on the least porous surface and applied evenly with a toothed spatula. The amount to apply will vary depending on the surface to be bonded. Carefully press the materials to be fixed onto the surface and, where necessary, use wedges or adhesive tape during the initial setting phase of the product.

Always use suitable personal protective equipment. Always consult the product's technical and safety information sheets before use.
